KEEP LAKE EDWARD HEALTHY

- Remove all visible plants from your boat before leaving a water access;
- Drain water from your boat, motor, livewell, and bait containers;
- Dispose of unwanted bait in the trash; and
- Spray, rinse or dry boats and recreational equipment before transporting to another water body

The regulations are to help prevent

the spread of AIS, aquatic invasive species. Eurasion milfoil, curly leaf pondweed, spiny water fleas and zebra mussels have already spread to some of the lakes in our region. At this point none of the invasive species have been spotted in Lake Edward. Let's keep it that way.

The Lake Edward District Conservation Club, Inc. was formed and officially incorporated in 1949. Its primary focus at that time was to enhance the fishing and hunting for the residents on and around the lake and

to support those enforcing game laws. The organization was successful but in later vears failed to meet and function organizationally.

In 1994, the organization was meeting is held in August. reactivated and a new board elected. The name was changed by dropping district. It is now officially Lake Edward Conservation Club, Inc. (LECC) and annual

reports are filed with the Minnesota Secretary of State. Membership is granted to those living on the lake permanently or part time and to those interested persons living in the area or using the lake. The LECC essentially

functions as a lake association. Two meetings are held each year. The annual

membership meeting is held in June and an open board Attendance at both meetings is encouraged and welcomed.

Lake Levels

With all the snowmelt and rain this spring, Lake Edward has risen to near normal levels. The lake has reached an elevation where it might just begin to flow out the outlet culvert under CR 4 behind the Y - Store. That is, the water might begin to flow out if there were no beaver dams in the outlet channel. Some beaver dams were partly removed from the channel in early June, but it doesn't take long for beavers to repair their dams, unless you can get rid of the beavers.

Thirty Lake Watershed District advised several LECC board members that Thirty Lakes Watershed has hired a trapper to remove beavers from the area around the outlet channel. But even trapping is only a temporary solution. Beavers move around to find new territory. As soon as the trapper left, other beavers would likely move in and restore the dams in the outlet channel.

> We discussed with Thirty Lakes board members, the possibility of installing something called a "Clemson beaver pond leveler." The leveler is an eight-inch PVC pipe placed through each beaver dam to allow a continuous flow. There is a baffle on each end of the pipe so the beavers don't sense the water flow and try to stop the water by expanding the dam. The levelers would cost a few hundred dollars each. Thirty Lakes board members plan to explore the idea and perhaps install one as a test. Levelers are known to work very well to maintain normal water

levels.

No need to worry yet, but if it begins to rain a lot, the lake may go up further. In that case, the levelers might not carry enough water to help lower the lake in a timely manner. If that happens, we might need to completely remove beaver dams in the outlet channel until the lake returned to more normal levels. No need for that yet, we're just thinking ahead to possible situations.

The naming of lakes in this



region often was traced to families that settled in this area. For example, Mollie Lake was named after the wife

of an early pioneer and Hubert was the first name of Hubert Beldon, who conducted the first survey of the area in 1858. The naming of other lakes in this region remain a mystery. Lake Edward falls into the later group. Lake Edward first appeared on a survey map in 1857 produced by a team lead by Hubert Belden. The lake was poorly outlined on Belden's map and nameless. A second survey team led by a fellow named Darling in 1858 names the body of water as Edward. But according to Carl A. Zappe, author of Oldtimers II Stories of our Pioneers

"We do not know whom the "Edward" refers."
