Only You Can Prevent

Did you fill in the blank with "forest fires"? Only you can prevent forest fires was a common and often used phrase many years ago. In 1944 the Forest Service introduced a bear as their campaign symbol. Smokey the bear pointed directly at the viewer when repeating that phrase. With a little twist that phrase can be modernized and used today, not for fires but for invasive species. Only you can prevent invasive species from entering Lake Edward. Why you? Gaining traction is the theory that lake shore

property owners are more responsible for the spread and containment of invasive species than boats launched at a public access, a current popular theory. Used equipment like docks and boat lifts may contribute more to the spread of invasive species than any other means. That's why it might be appropriate to say, "Only you can prevent invasive species from entering Lake Edward". Be cautious when purchasing any used equipment that enters the water. Visual inspection is important but the culprits are tiny and often hard to find. The surest way to ensure the equipment you put in the lake is safe is to place it in quarantine for twenty one days. A small price to pay for a clean lake.



Power



"Power loading", can cause damage to launch ramps that may not be visible from the surface of the water. "Power loading" is a term used to describe using the motor to load and unload the boat onto and off the trailer. There is some evidence of damage from power loading at the Lake Edward boat ramp. Many of the state's 3,000 public launch ramps were not designed to sustain the forces generated by today's larger and more powerful boats or the practice of power loading. Propeller wash creates a significant force that can erode the lakebed and create a large hole at the end of the ramp. Eroded material is often deposited beyond the ramp to create a mound, which can result in a barrier for launching and loading. Boats and equipment can incur damage if the boat or lower unit runs aground on the mound or if the trailer becomes stuck in the hole. In the worse cases, the end of the ramp could collapse, resulting in an unusable launch ramp. In low water conditions the mound created from propeller wash can obstruct launching and loading.

DNR crews have been busy rehabilitating damaged launch ramps statewide. Staff are repairing the holes and extending the ramps by adding additional concrete planks. When possible the mounds are leveled with excavation equipment. These launch ramp repairs are time consuming and expensive.

The DNR recognizes that some boaters are accustomed to power loading. However, it is preferable that boaters do not race their engines while on the boat ramp. Slightly more than idle speed should be all that is necessary to load and/or unload the boat. The best practice is for boaters to refrain from power loading and use the winch to load and unload their boat.



Hammer-handles

This area is popular because of the recreational opportunities it offers. The lakes in our area offer a valuable resource providing boating and fishing opportunities. With more and more people taking advantage of the recreational possibilities and the rapid rise of technology more pressure is put on fish populations. Old photos show stringer after stringer of large walleyes caught in the lakes in our area. Landing a lunker isn't as easy as it once was. A researcher having studied the problem for many years has come to a theory. He believes he knows why there are smaller and fewer walleye in our lakes. The theory that is gaining traction has to do

with northerns specifically hammer-handle northerns. The more hammer-handle northerns in a lake the smaller and fewer the number of walleye exist. Large population of small northerns don't allow walleye to survive past their second autumn, or sunfish or perch for that matter. In fact one of the many new regulations for increasing the number of walleye on Mille Lacs establishes a northern limit of ten instead of the present three. The theory being walleye might have a fighting chance if there were less predators to eat them. There is no reason this theory doesn't hold for all lakes. Since Lake Edward has the perfect spawning grounds for northerns it might apply even more here. If harvesting more hammer-handle northerns to reduce their populations will have an positive affect on walleye down the road it might be advantages to try and max out on the limit of northerns when you are fishing our lake. Solving one problem, too many small northerns, may lead to another, what to do with all those hammer-handles. The internet is loaded with videos on removing "Y" bones from a northern, a major complaint of northerns. Just do a search on removing "Y" bones and take your pick of videos. Don't want to deal with the "Y" bones? There are numerous pickling recipes as another option. The internet provides information on pickling too. Oh, and by the way the other aspect of the hammer-handle theory is to catch and release all large pike. Large pike bring stability to a lake.

Lake Edward it is still three.

You may have seen articles about a chemical, Zequanox, a control agent to contain zebra mussels. The agent contains dead bacterial cells. When a zebra mussel eats them it's digestive tract is disrupted leading to the mussel's death. The excitement of the discover of this agent must be tempered with the realization that Zequanox has

proven to be effective only in small applications. It would be unrealistic to think it could be used to control mussels throughout an entire lake. According to the inventor, don't hold your breath waiting for this research solution to arrive, because it is a least a decade away. In addition it is an extremely expensive chemical unaffordable by any lake association. The best strategy continues to be control. Be wary of everything that you put in the lake.

There was plenty of snow on the ice, making it tough to ice fish But the snow cover was a good thing in one way. Curly leaf pondweed (CLP) is an exotic species in Lake Edward that grows under the ice all winter But even CLP needs sunlight, so the snow cover should have helped keep out CLP crop in check. I say should have, but we really don't know. We plan to use Lowrance depth finders to survey CLP this spring to produce accurate maps of CLP. More on that later. Lori Nelson has produced a directory of lakeshore owners. Dues paying members get a free copy at the June meeting or at my house. Please attend the annual meeting on June 14 at 10 AM at the Merrifield Marathoners Club across from Super America.

Trivia answer from question on page 1

Baby Face Nelson and his gang robbed the First National Back of Brainerd in 1933. All five escaped with \$32,000 in a flurry of bullets. They had cased the bank for at least ten days before the robbery while staying a resort on Round Lake. At least one report had the bandits stashing the loot in the Lake Edward log School House. The school was located, at the time, between Mollie and Lake Edward.

It's not uncommon for lakeshore property owners to return to their cabins in the spring to find damage to their shoreline, docks, boat lifts, retaining walls and sometimes to the cabins themselves. What causes this?

This type of property damage is caused by a phenomenon called "ice heaving" or "ice jacking." As ice freezes and thaws, cracks form because of the different contraction rates at the top and bottom of the ice sheet. This is especially true in years when there's a lack of insulating snow cover. When water rises in cracks and freezes, the ice sheet expands slightly. Rising air temperatures warms the ice, which causes the additional expansion to exert a tremendous thrust against the shore. This powerful natural force forms a feature along the shoreline known as an ice ridge. These ridges can sometimes reach as high as five feet or more. Additional warming and cooling of an ice sheet can cause additional pushing and exert enough pressure to nudge bridge masonry piers out of plumb and push houses off their foundations.


Your Lake Edward Directory Now Available
